The following table presents the standard accreditation (initial and reaccreditation) fees for each of the top four international business-school accreditations as stated on the websites of the relevant accreditation bodies as at 07 March 2024.

** Please note, these costs should be taken as a guide only. Final costs should always be confirmed with the relevant accreditation body.**

Costs are for a standard accreditation / reaccreditation process (<u>without</u> additional site-visits, deferrals etc). For AMBA and EFMD Accredited Programmes, costs relate to a single programme or programme set. For AACSB, it refers to Business Accreditation only.
